

COMMISSIONERS' PROCEEDINGS  
CLOUD COUNTY, KANSAS  
JULY 25, 2022  
UNOFFICIAL PROCEEDINGS

Regular session of the July meetings of the Cloud County Board of Commissioners was called to order at 9:00 a.m. on July 25, 2022 in the Commissioners' room at 811 Washington, Concordia, Kansas with Chairman Ron Copple, Members Bill Czapanskiy and Gary Caspers, and County Clerk Shella Thoman present.

County staff attending was: Andy Asch, Highway Administrator.

Others attending: Toby Nosker, KNCK; Richard Schultz, Miltonvale Rural fire; and Casey Fraser, Foley Equipment; Mark Budreau, Budreau Construction.

Mark Budreau, Budreau Construction presented the warranty information for the Law Enforcement Center.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board approved allowing the Chairman to sign the warranty on the Law Enforcement Center project.

Received a Temporary Certificate of Occupancy for the Law Enforcement Center on the condition that a fire watch is required until the fire alarm/smoke control systems are 100% operational and tested and must be completed within 90 days beginning July 19, 2022.

Andy Asch, Highway Administrator discussed the Road Use agreement for Plum Nellie, reported that he would be attending a pre-construction meeting with KDOT regarding the southbound lanes of Highway 81 north of Union to the County line and possible intersection closure. The project is estimated to begin August 1<sup>st</sup> with a completion date around Thanksgiving. Continuing to spray for Johnson grass.

Richard Schultz, Miltonvale Fire Chief discussed issues with the new radio system.

Casey Fraser, Foley Equipment thanked the Board for the business.

Recognized the wage change for Dawn Snyder to \$35.89 effective July 1, 2022.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board approved advising Shirley Township that an application has been filed with Cloud County by Tamera Barnes, St. Joe Café & Store for a Cereal Malt Beverage License.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board approved Resolution 2022-15 appointing Chris Springer, Belleville Chief of Police be appointed as a member of the 12<sup>th</sup> Judicial District Community

Corrections/Juvenile Justice Authority Advisory Board representing Republic County law Enforcement.

On a motion by Commissioner Caspers, second by Commissioner Czapanskiy, unanimous vote the Board approved the Chairman to sign the Regional Hazard Mitigation Plan participation.

On a motion by Commissioner Caspers, second by Commissioner Czapanskiy, unanimous vote the Board approved signing the Notification of County Appraiser Change effective July 15, 2022.

On a motion by Commissioner Caspers, second by Commissioner Czapanskiy, unanimous vote the Board approved Resolution 2022-16 appointing Toby Marco as Cloud County Appraiser.

Sales tax received July 22, 2022 totaled \$85,129.28 compared to the prior year totaling \$75,571.56.
