Andy Asch, Highway Administrator reported he would be applying for Local Bridge Improvement funds for the U.P. bridge. KDOT will be shutting down the southbound lanes this week for repairs on Highway 81 from the County line to north of Union Road.

Tonya Sulanka, Health Department Administrator presented resignations, reported the Fire Marshal will be doing an inspection, had no deficiency's on the COVID / Immunization audit and the parapet is complete.
