

COMMISSIONERS' PROCEEDINGS  
CLOUD COUNTY, KANSAS  
OCTOBER 31, 2022  
UNOFFICIAL PROCEEDINGS

Regular session of the October meetings of the Cloud County Board of Commissioners was called to order at 9:00 a.m. on October 31, 2022 in the Commissioners' room at 811 Washington, Concordia, Kansas with Chairman Ron Copple, Members Bill Czapanskiy and Gary Caspers, and County Clerk Shella Thoman present.

County staff attending was: Andy Asch, Highway Administrator; and Tonya Sulanka, Health Department Administrator.

Others attending: Toby Nosker, KNCK; and Alisha Bond, HUB.

Tonya Sulanka, Health Department Administrator reported they would be going to the jail to overview the nursing needs before completing the agreement and that Christy Rogers last day will be November 17<sup>th</sup>; she is being replaced by Julie Redden.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board approved hiring Lois Tracey as WIC Clerk at an hourly rate of \$15.88 an hour effective October 31, 2022.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board approved the classification change for Chelsey Simon from WIC Clerk to Office Manager with a wage change from \$15.88 to \$17.00 effective October 31, 2022.

Andy Asch, Highway Administrator reported that signs were stolen from the UP Bridge.

Alisha Bond, HUB discussed Health Insurance renewal and options. No decision was made.

Shella Thoman, County Clerk reported that 8 employees participated in the Pumpkin Decorating contest and raised \$57.29. Noah Thoman (Recycling) and Doug Colby's (Sheriff) pumpkins raised the most money and each will receive a day off with pay that must be used by December 17<sup>th</sup>.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board approved using \$150.00 of Wind Farm money to support the Cloud County Food Cupboard including the \$57.00 raised from the employee Pumpkin contest.

On a motion by Commissioner Caspers, second by Commissioner Czapanskiy, unanimous vote the Board approved Transfer 2022-1031-1 debiting Co. General – Sheriff/Contractual and crediting Co General – Sheriff/Commodities for \$4,800 to fix the fund on check #216657.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board approved Transfer 2022-1031-2 and 2022-1031-3 debiting Co. General – Jail/Contractual and crediting Co General – Jail/Commodities totaling \$148.59 to fix the fund on check #216719 and check # 216676.

On a motion by Commissioner Caspers, second by Commissioner Czapanskiy, unanimous vote the Board approved the classification change for Noah Thoman from part-time Recycling Sorter to full-time Equipment Operator and an hourly wage change to \$14.00 for an introductory period of 90 days effective October 31, 2022.

Sales tax received October 26, 2022 totaled \$74,250.31 compared to the prior year totaling \$71,171.75.

The Board had the opportunity to review the Transcript of proceedings of the Converted refunding revenue bonds, Series 2020 (Law Enforcement and Detention Center project), of Cloud County, Kansas Public Building Commission, originally dated March 10, 2020.

The Board approved the following payroll expenses totaling \$165,870.16
