

COMMISSIONERS' PROCEEDINGS
CLOUD COUNTY, KANSAS
NOVEMBER 28, 2022
UNOFFICIAL PROCEEDINGS

Regular session of the November meetings of the Cloud County Board of Commissioners was called to order at 9:00 a.m. on November 28, 2022 in the Commissioners' room at 811 Washington, Concordia, Kansas with Chairman Ron Copple, Members Bill Czapanskiy and Gary Caspers, and County Clerk Shella Thoman present.

County staff attending was: Andy Asch, Highway Administrator; and Nancy Owen, Deputy County Appraiser.

Others attending: Toby Nosker, KNCK; and Casey Fraser, Foley Tractor.

Casey Fraser, Foley Tractor thanked the Board for their support in 2022.

Andy Asch, Highway Administrator reported that they have a part-time position open and discussed longevity requirements including continuing to pay \$50 a year past the 20-year cap.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board approved removing the 20-year longevity cap, paying \$50 a year for the total calendar years of service.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board approved hiring James (JD) Beam as a Mechanic at an introductory rate of \$16.52 for 6 months effect December 4, 2022.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board approved a 10-minute executive session for personnel exception to discuss non-elected personnel including Nancy Owen and Shella Thoman resuming open session at 9:58 a.m.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board approved the November 21, 2022 Election Canvass minutes and signed the permanent election records.

The County received a \$2,250.00 check from KWORCC to reimburse training fees for 9 employees to attend the Kansas Sheriff's Jail Training Academy.

Sales tax received November 23, 2022 totaled \$93,445.06 compared to the prior year totaling \$67,937.84.

Cloud County employees will be ringing the Salvation Army bells December 8, 2022 at Wal-Mart.

The Board approved the following payroll expenses totaling \$169,881.61

Appraiser - \$5,705.14 County Health - \$20,365.87
Noxious Weed - \$1,804.49 Election - \$1,752.23
Solid Waste - \$6,017.06

Payroll Deductions & Benefits - \$207,185.72

On a motion by Commissioner Caspers, second by Commissioner Czapanskiy, unanimous vote the Board approved abatements 2022-122, 2022-141 thru 2022-143 with a net change of -624.92 and no refund.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board approved the November 28, 2022 minutes as presented.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board adjourned at 10:06 a.m., until Monday December 5, 2022.
