CLOUD COUNTY, KANSAS  
APRIL 18, 2022  
UNOFFICIAL PROCEEDINGS

Regular session of the April meetings of the Cloud County Board of Commissioners was called to order at 9:00 a.m. on April 18, 2022 in the Commissioners' room at 811 Washington, Concordia, Kansas with Chairman Ron Copple, Members Bill Czapanskiy and Gary Caspers, and County Clerk Shella Thoman present.

County staff attending was: Andy Asch, Highway Administrator; Mike Hake, Solid Waste Director; and Robyn Brooks, COVID Care Coordinator.

Others attending: Marlene Stamm, County Sanitarian.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board approved a 10-minute executive session for personnel exception to discuss non-elected personnel returning to open session at 9:10 a.m. and including Robyn Brooks and Shella Thoman.

Andy Asch, Highway Administrator reported that the lawsuit against Coughlin Company has been filed. He will have a conference call with FEMA this week in regards to the December storm and gravel loss. Cold mix has increased to \$86.75 a ton, \$11 more a ton than last year.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board approved a utility permit for Clinton Fraser of Cloud County Rural Water District #1 for 145<sup>th</sup> road off of Key.

Mike Hake, Solid Waste Director reported he sold 39,981 lbs. of cardboard at \$160 a ton. Received one quote for road repairs from Hall Bros, will get additional quotes. Working with Cheney Door Company in Salina.

Marlene Stamm, County Sanitarian presented a quarterly report.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board approved distributing \$238,855.00 of Wind Farm funds to:
