

COMMISSIONERS' PROCEEDINGS
CLOUD COUNTY, KANSAS
APRIL 25, 2022
UNOFFICIAL PROCEEDINGS

Regular session of the April meetings of the Cloud County Board of Commissioners was called to order at 9:00 a.m. on April 25, 2021 in the Commissioners' room at 811 Washington, Concordia, Kansas with Chairman Ron Copple, Members Bill Czapanskiy and Gary Caspers, and County Clerk Shella Thoman present.

County staff attending was: Ken Davis, Sheriff; Andy Asch, Highway Administrator; Tonya Sulanka, Health Department Office Manager; and Dawn Snyder, Community Corrections / JJA Assistant Director.

Others attending: Toby Nosker, KNCK.

Andy Asch, Highway Administrator presented a utility permit, reported they were looking for a replacement truck to pull the skid steer and discussed the Road Agreement for Skyview Wind Windfarm.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board approved the utility permit for Wayne Gardner of EAC Every Angle Covered for a private water line 290 ft west of 145th.

Dawn Snyder, Community Corrections / JJA Assistant Director presented grant applications for approval.

On a motion by Commissioner Caspers, second by Commissioner Czapanskiy, unanimous vote the Board approved the Fiscal Year 2023 Adult Comprehensive Plan Grant for \$343,160.55.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board approved the Fiscal Year 2023 Juvenile Comprehensive Plan Grant in the amount of \$296,852.98.

On a motion by Commissioner Caspers, second by Commissioner Czapanskiy, unanimous vote the Board approved the Fiscal year 2023 Reinvestment Grant Funds Budget Summary and Budget Narrative in the amount of \$47,201.00.

On a motion by Commissioner Caspers, second by Commissioner Czapanskiy, unanimous vote the Board approved hiring Austin Wilson as a Corrections Officer to fill an open position at an hourly rate of \$16.00 effective April 22, 2022 to fill an open position.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board approved disbursing 70% of the \$20,005 Emergency

Management Performance grant (EMPG) to Emergency Preparedness Director James Quillen, evenly for the remaining pay periods for 2022.

Shella Thoman, County Clerk reported that the County is signed up for the Give Back Kansas program hosted by the Kansas Volunteer Commission. The challenge runs from April 18 – June 10 and the winning organization at each level will receive a \$1,000 donation to a nonprofit of their choice. Presented a draft copy of a Time Clock policy. Discussed Wind Farm disbursement payments.

On a motion by Commissioner Caspers, second by Commissioner Czapanskiy, unanimous vote the Board approved a 15-minute executive session for personnel exception to discuss non-elected personnel returning to open session at 10:50 a.m. and including Tonya Sulanka, Health Department Officer Manager and Shella Thoman.

On a motion by Commissioner Caspers, second by Commissioner Czapanskiy, unanimous vote the Board appointed Tonya Sulanka as the Health Department Interim Director effective April 25, 2022 with additional pay of \$350.00 per pay period.

The Board recognized the resignation of Brandi Bray, Health Director effective May 11, 2022.

The Board received a thank you note from the City of Jamestown for the Windfarm grant approval.

The Board approved the following expenses totaling \$232,274.67.

On a motion by Commissioner Caspers, second by Commissioner Czapanskiy, the Board approved abatements 2022-86 through 2022-88 with a net change of \$443.30 and refund totaling \$151.72.

On a motion by Commissioner Caspers, second by Commissioner Czapanskiy, unanimous vote the Board approved the April 18, 2022 minutes as presented.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board adjourned at 12:10 p.m., until Monday May 2, 2022.
