COMMISSIONERS' PROCEEDINGS CLOUD COUNTY, KANSAS JUNE 27, 2022 UNOFFICIAL PROCEEDINGS

Regular session of the June meetings of the Cloud County Board of Commissioners was called to order at 9:35 a.m. on June 27, 2022 in the Commissioners' room at 811 Washington, Concordia, Kansas with Chairman Ron Copple, Members Bill Czapanskiy and Gary Caspers, and Deputy County Clerk Cathy Davis present.

County staff attending was: Andy Asch, Highway Administrator

Others attending: Republic County Commissioners: Ed Splichal, Doug Garman, and Melvin Jeardoe; Kathleen Marsicek, Republic County Clerk (Republic County by conference call).

Andy Asch, Highway Administrator discussed wages for his department; presented a classification change for Zak Romo, from Equipment Operator to Asphalt Foreman with a wage of \$17.52, with a 3 month introductory period, effective July 3, 2022; working on Fawn Rd; dragging dirt roads and working on gravel roads; Acorn Rd between 120<sup>th</sup> and 130<sup>th</sup> roads is back open and discussed FEMA money he has received from 2019 storms.

On a motion by Commissioner Czapanskiy, second by Commissioner Caspers, unanimous vote the Board acknowledged the change of classification for Zakary (Zak) Romo, from Equipment Operator to Asphalt Foreman with a wage of \$17.52, with a 3 month introductory period, effective July 3, 2022.
