

COMMISSIONERS' PROCEEDINGS
CLOUD COUNTY, KANSAS
JANUARY 3, 2022
OFFICIAL PROCEEDINGS

Regular session of the January meetings of the Cloud County Board of Commissioners was called to order at 9:00 a.m. on January 3, 2022 in the Commissioners' room at 811 Washington, Concordia, Kansas with Chairman Gary Caspers, Members Bill Czapanskiy and Ron Copple, and County Clerk Shella Thoman present.

County staff attending was: Andy Asch, Highway Administrator; Brandi Bray, Health Department Administrator; Jerry Collins, IT Director; and Eric Gennette, Custodian.

Others attending: Toby Nosker, KNCK

Andy Asch, Highway Administrator presented a resignation and reported they were working on snow removal.

Accepted the Resignation of Daniel Lahodny, Highway Department Utility Worker effective December 22, 2021; Cynthia Dew, Custodian and Henry Eilert, Maintenance Director effective December 27, 2021.

Brandi Bray, Health Department Administrator reported new COVID-19 guidelines have been released. The guidance is broken down for Health Care workers and the general population and takes into consideration vaccinated, unvaccinated, prior infection, the booster, if the person is asymptomatic, positive or a close contact.

On a motion by Commissioner Czapanskiy, second by Commissioner Copple, unanimous vote the Board approved a 5-minute executive session for personnel exception to discuss non-elected personnel including Bray and Thoman returning to session at 10:04 a.m.

Eric Gennette, Custodian discussed routine business.

On a motion by Commissioner Czapanskiy, second by Commissioner Copple, unanimous vote the Board approved the classification change for Eric Gennette, Custodian from \$13.80 to \$14.25 effective January 3, 2022.

Jerry Collins, IT Director discussed department operations and presented contact information.

On a motion by Commissioner Cople, second by Commissioner Czapanskiy, unanimous vote the Board approved Resolution 2022-1 designating the Concordia Blade-Empire the Official County Newspaper.

On a motion by Commissioner Cople, second by Commissioner Czapanskiy, unanimous vote the Board approved Resolution 2022-2 concerning waiver of generally accepted accounting principles.

On a motion by Commissioner Czapanskiy, second by Commissioner Cople, unanimous vote the Board approved Resolution 2022-3 designating all Cloud County banking institutions depositories for all public moneys in the hands of the County Treasurer.

On a motion by Commissioner Czapanskiy, second by Commissioner Cople, unanimous vote the Board approved Transfer 2021-1231-1 debiting Special Bridge/Contractual Services \$42,485.37, Special Bridge/Commodities \$43,297.47 and Special Bridge/Capital Outlay \$8,420.10 and crediting Road & Bridge/Reimbursed Expenses \$94,202.94 for bridge projects.

Sales tax received December 27, 2021 totaled \$89,896.82 compared to the prior year totaling \$73,029.18. The tax yearly sales tax for 2021 was \$872,689 in comparison to 2020 totaling \$814,302.16
